Vocabulary for Terror at Bottle Creek



Here is a picture of a swamp. There are a lot of words used in the story that all relate to water: swamp, slough, bayou, marsh, river, creeks. Hopefully, these definitions will help you understand what they mean.

- swamp: An area of low-lying ground where water collects, often called a bog or marsh.
- bayou: A marshy outlet of a lake or river.
- slough: (pronounced sloo like the color blue OR slou so that it rhymes with cow)
- A channel of water that moves through a swamp, similar to a river but the water moves very slowly, and it is much smaller than a river.
- creek: A stream, brook, or minor tributary of a river.

Don't worry if you don't really understand the difference in each of these words. Just know this: the river is the larger body of water that floods and creates the swamp. Bayous, creeks, and sloughs are similar to rivers, but smaller and the water usually moves slower in them.
